# **GENERAL INFORMATION**

The Canada-Italy Codevelopment Incentive is a collaboration between the Canada Media Fund (CMF) and the Directorate General Cinema of the Italian Ministry of Cultural Heritage, Activities and Tourism ("DGC") to fund the codevelopment of eligible one-off documentary projects between producers from Canada and Italy. Applicants should be familiar with the 2016-2017 Canada-Italy Codevelopment Incentive Guidelines prior to completing this application form.

## **CLOSING DEADLINE FOR APPLICATIONS: JANUARY 24, 2017**

Projects will be assessed by a selection committee composed of CMF and DGC representatives.

\*\*Each co-producer will be responsible to submit the complete application to the authority (CMF or DGC) of its own country.

The same set of documents must be submitted by each co-producer and the application form must be signed by all co-producers.\*\*
